March 5, 1941 - December 2, 2025

Judge James Hardy Payne (March 5, 1941 - December 2, 2025)

James Hardy Payne, 84, of Tulsa, Oklahoma, after a prolonged battle with multiple health issues, entered into the presence of his Lord and Savior on December 2, 2025. A longtime member of the Eastern Oklahoma legal community, Jim practiced law in Muskogee before serving as a United States District Judge in both Muskogee and Tulsa for nearly twenty years.

Jim was born on March 5, 1941, in Lubbock, Texas to Hollis Lee and Leona (Hecht) Payne. He later moved with his parents and younger sister (Carol Ann) to Stamford, Texas where he graduated from high school in 1959. Jim (known then as “Jimmy”) was a member of two Texas high school state championship football teams (1956 and 1958) and was named to the Texas Sports Writers AA All State football team (1st team) in 1958.

In 1959, he received a football scholarship from the University of Oklahoma where he played for legendary coach Bud Wilkinson. Jim lost his father while in high school and Wilkinson became a mentor to him. He made lifelong friends as a student-athlete at OU and was an avid Sooner football fan.

In 1963, Jim graduated from OU with a Bachelor of Science degree.

On September 7, 1963, he married Judith (“Judy”) Mills. She was a year behind him in school in Stamford and also attended college at OU. Though they grew up together in Stamford, Jim and Judy did not start dating until they were both at OU.

Coach Wilkinson encouraged Jim to consider law school, and in 1963 he enrolled at OU’s College of Law. He graduated with a JD from OU in 1966. During his law school years, he helped coach OU’s football team as a graduate assistant under Coach Wilkinson.

Between 1966 and 1970, he served as a JAG officer in the United States Air Force with the Strategic Air Command at Columbus AFB in Columbus, Mississippi. He served a temporary duty assignment at Andersen AFB in Guam and was discharged from active duty in 1970. During his time in Columbus, Jim and Judy had two children - their son, Jon, and daughter, Julie.

In 1970, he moved with his family to Oklahoma where Jim served as an Assistant US Attorney for the Eastern District of Oklahoma in Muskogee. In 1973, he entered private practice with Forney Sandlin, and together they formed the firm of Sandlin and Payne in

Muskogee. He served as a part-time United States Magistrate Judge for the Eastern District during his years of private practice.

In 1975, Jim resumed his Air Force service as a reserve JAG officer, serving first at Sheppard Air Force Base in Texas and later at Tinker Air Force Base in Oklahoma. He retired from the Air Force in 1992 as a Lieutenant Colonel.

In 1988, he was appointed to a full-time United States Magistrate Judge position in the Eastern District of Oklahoma. As a Magistrate Judge, he

worked with others including Judge Frank Seay on a case that became a subject of John Grisham's well-known book, *The Innocent Man*. Grisham described Judge Payne in the book as a “hero.”

On September 4, 2001, President George W. Bush nominated him to a United States District Judge position. The United States Senate confirmed his nomination on October 23, 2001, by unanimous vote (100 to 0) and he received his commission on October 24, 2001. He kept chambers and received cases in both the Eastern and Northern Districts and served as the Chief Judge of the Eastern District between 2002 and 2017. He transitioned to inactive senior status in 2020. Judge Payne thoroughly enjoyed his judicial duties and would likely have continued in his position had his health allowed him to do so.

He had great friends at the courthouse including his longtime assistant and many excellent law clerks with whom he greatly enjoyed working during his tenure. A beautiful oil painting portrait of Judge Payne hangs in the ceremonial courtroom in the Eastern District of Oklahoma in Muskogee.

After living in Muskogee for more than 50 years, Judge Payne moved with Judy to Tulsa to be closer to their children and grandchildren. During the last chapter of his earthly life, he lived at Montereau in Tulsa where family members and Montereau staff lovingly cared for him. He drew the admiration of his caregivers and was affectionately known at Montereau as “Judge.”

Judge Payne was a member of St. Paul United Methodist Church in Muskogee for more than 50 years; a member of the Oklahoma Bar Association, the Varsity O Club, a fellow of the American Bar Association; a member of the Fellowship of Christian Athletes, a past president of the Muskogee Rotary Club; and a member of the Sigma Chi Fraternity while

attending OU.

Judge Payne was a devoted Christian who invested heavily in his family and community. At St. Paul, he served as a youth leader along with Judy, coached a church

basketball team, and taught Sunday school classes. He helped found an FCA chapter in Muskogee and frequently spoke to high school athletes. He loved spending time with Judy, his children and their families, and lovingly attended grandchildren's activities including sporting events as well as dance and other performances. As a big Sooner fan, he attended many OU football games over the years with his family.

Judge Payne is survived by his wife of 62 years, Judith Mills Payne of Tulsa; a son, Jon Payne and his wife Karri of Tulsa; daughter Julie Payne Woolslayer and her husband John of Tulsa; six grandchildren: Matthew James Woolslayer and his wife Brooklynne of Tulsa; Jackson Robert Woolslayer and his wife Landes of Lake Mary, FL; John Philip Woolslayer of Savannah, GA; U.S. Army 2nd Lt. James ("Ben") Payne and his wife Celie of Clarksville, TN; Jillian Beatrice Payne of Tulsa, and Sarah Katherine Woolslayer of Tulsa; two great-grandchildren: Michael Hardy Woolslayer of Tulsa, and Davis Payne Woolslayer of Lake Mary, FL; a sister, Carol Ann Armstrong and her husband Terry of Garden Ridge, TX; a brother-in-law Jack Mills and his wife Cirrelda of Boulder CO; two nieces: Deborah Mills Stamets and her husband Chris of Scottsdale AZ; Mary Mills Schrock and her husband Brad of Steamboat Springs, CO; and nephew Tom Mills and his wife Sue of Lafayette, CO.
